

Cleopatra Hospitals Group Announces the Launch of Cleopatra El Tagamo (Sky) Hospital, Setting a New Benchmark for Advanced Healthcare in East Cairo

Cleopatra Hospitals Group ("CHG"), Egypt's leading private healthcare platform, has officially launched Cleopatra El Tagamo (Sky) Hospital, its latest flagship facility in East Cairo. The launch reinforces CHG's long-term growth strategy and its role as a key private-sector partner in Egypt's healthcare transformation agenda, aligned with national priorities to expand high-quality healthcare infrastructure and advance public-private partnerships ("PPP").

Operating under a PPP model with ownership by the Ministry of Petroleum and Mineral Resources, the hospital was fully developed, fitted and equipped, and is managed by CHG, with total investments reaching up to EGP 3.5 billion. As the exclusive operator and manager, CHG fully consolidates the hospital's operations into its financial statements, supporting earnings growth as the facility ramps up. It will operate at a total capacity of 240 beds approximately at full scale, with a phased ramp-up and full operational capacity targeted within its first year of operation.

The inauguration was attended by H.E. Dr. Mostafa Madbouly, Prime Minister of Egypt; H.E. Dr. Khaled Abdel Ghaffar, Deputy Prime Minister for Human Development and Minister of Health and Population; H.E. Eng. Karim Badawi, Minister of Petroleum and Mineral Resources; the Presidential Advisor for Health and Prevention Affairs; and senior government officials, reflecting strong institutional backing for private-sector participation in healthcare delivery.

Commenting on the launch, Dr. Ahmed Ezz El-Din, CEO of Cleopatra Hospitals Group, said:

"The opening of Cleopatra El Tagamo (Sky) Hospital marks a pivotal strategic milestone for our network. It not only reinforces our geographic and service-line expansion but also strengthens our capacity to deliver world-class care that responds to both domestic and regional demand. This investment further demonstrates our commitment to sustainable, demand-driven growth and value creation for our shareholders."

With strong fundamentals, ongoing capacity expansion, and an increasing pipeline of high-value service offerings, CHG remains well positioned to deliver sustainable growth, enhance profitability, and expand both domestic and cross-border healthcare access.
